



**Boarding Agreement**

1. All horses shipped into **Bluestone Farms, L.L.C.** with the expressed purpose of remaining as boarders, regardless of the length of stay, **MUST** be accompanied by a current negative Coggins Test.
2. All horses shipped into **Bluestone Farms, L.L.C.** with the expressed purpose of remaining as boarders, regardless of the length of stay, should be vaccinated for Potomac Fever, Botulism, Rhino pneumonitis, Encephalomyelitis, Tetanus, Influenza, Strangles, West Niles, and Rabies. If a horse(s) arrives at **Bluestone Farms, L.L.C.** without a vaccination chart, the horse(s) will be vaccinated upon arrival, at the owner's expense.
3. Board is charged on a daily rate in accordance with the schedule below. In addition, veterinarian and other expenses such as, but not limited to, trimming feet, x-rays, injections, worming, palpation, ultrasound, and health certificates are the sole responsibility of the owner.
4. **Bluestone Farms, L.L.C.** will exercise reasonable care of all horses boarded at the farm. The farm will perform the customary practices, within the Standardbred Industry, for the protection, health and safety of all horses in its care. However, **Bluestone Farms, L.L.C.**, its manager, agents, servants and/or employees cannot assume any liability for theft, loss, injury, disease, or death of any horse in its care, nor for any injury, disease or death of any mare resulting from breeding or attempted breeding to any stallion(s), unless it is established by clear and convincing evidence that the farm is guilty of gross negligence.
5. **Bluestone Farms, L.L.C.** reserves the right not to release any horse in its care until all charges incurred to the owner(s) of said horse(s) are paid. Overdue accounts will be charged a late fee of 1.5% per month. Owners are responsible for all costs associated with the collection of their overdue balances including but not limited to Attorney's fees and filing fees.
6. If this agreement is signed by one owner, when the horse(s) is owned by multiple owners, all owners will be bound by the terms and conditions of this agreement. If this agreement is signed by an agent for the owner(s), then the agent and all owners will be bound by the terms and conditions of this agreement.
7. If any horse is sold or transferred between owners while in the care of **Bluestone Farms, L.L.C.** the original owner(s) must notify **Bluestone Farms, L.L.C.** of the change. Notice must be made in writing to **Bluestone Farms, L.L.C.** within 10 days of the change of ownership. Failure to do so may result in additional charges to the original owner.
8. The owner of a horse(s) boarded at **Bluestone Farms, L.L.C.** hereby permits **Bluestone Farms, L.L.C.** to verify ownership with the United States Trotting Association and/or the Canadian Trotting Association and to provide any and all information **Bluestone Farms, L.L.C.** has, including but not limited to ownership, billing, health of a horse(s) to any State or Provincial Racing Commission that so requests.
9. This agreement is governed by the laws of the State of New Jersey.
